Editorial

Langbord update. In a surprise ruling on April 17, the Court of Appeals of the third circuit vacated the previous rulings against the Langbord family regarding the 1933 double eagles. This paves the way to return those coins to that family. The main reason for the ruling was the government's failure to file a judicial civil forfeiture complaint. The case has now been sent to a district court for further consideration. If the **Langbords** do receive the coins, how will this affect the value of the 1933 \$20? In 2002, the **Farouk** specimen sold for \$7.59 million. With an additional 10 specimens, the price is expected to fall to the \$1.5-2 million range. This price is in line with similar rarities such as the 1804 dollar and the 1927-D \$20. Knowing the government and the courts, this case is still a long way from being settled.

Hoover coin-medal sets. Since the start of the Presidential dollar series, one of the least known products of the mint is a set consisting of a dollar coin and a first spouse medal. The mint sells these sets for \$10 each. In 2014, the mint capped sales of the Harding, Coolidge and Hoover set at 4,500 and the FDR set at 7,000. In the secondary market the prices began to rise, especially the Hoover set. Currently the Hoover set is selling in the \$160-200 range. Market experts speculate the prices are driven by speculators and are in danger of crashing. They cite the 2013 offerings with similar mintages selling in the \$25-35 range.

Try and find these in change. In a recent Numismatic News viewpoint, James Evans wrote about the challenges of assembling a short set of recent circulating commemorative coins. The three sets mentioned are the Westward Journey nickels, the Lincoln cents of 2009 and the Territories quarters set. Each set consists of 8-12 coins but are seldom seen in circulation. It is easy to buy a set from a dealer but putting together a circulated set is tricky. Since reading the article, I am working on a nickel set. So far I found five of the eight. If you want to attempt this, good luck.



Coin of the month 1779 Rhode Island Ship Token

This month's coin of the month is the Rhode Island ship token of 1779. While this coin is listed in the Red Book, it is not an American issue but was actually struck in England and only circulated here when brought over by immigrants. After years of speculation, the current theory is this coin is a propaganda issue intended for use in the Netherlands. The subject of the coin is the victory of **Admiral Howe** over **Major General John** Sullivan and French **Admiral Comte d'Estaing** prompting the American and French to flee Rhode Island. The British then issued this coin to persuade the Dutch to side with the British against the Americans. This also explains why the inscriptions are in Dutch.

The obverse shows the flagship commanded by **Admiral Howe**. Around the ship is Der Admiraals flag von Admiral Howe, 1779 and on some specimens a small wreath. The reverse shows an unusual shaped land mass with soldiers walking right. To the left of the island are three ships. To the right are thirteen small boats. Around this image is D vlugtende Amiricaane van Rhode Yland augt 1778 and a floral design. This inscription roughly translates to the Americans fleeing from Rhode Island August 1778. The coin measures 32.4 mm and is struck in brass although some are known in pewter. Collecting this coin is not for beginners. Prices for the coin range from \$2,000 in AU to \$15,000 in mint state. Prices for pewter examples range from \$11,000 to \$39,000 in the same grades. As a side note, This coin was used as a minor plot point on the Fox TV show Family Guy where the coin was found under a carpet.
